Terms and Conditions

1. **Payment**—A deposit of **30%** of the total cost for coverage must be paid before the date is booked. The remaining balance (70% of the total cost for coverage) must be paid upon delivery of the finished DVDs, which should come 8 weeks after the event. *Make checks payable to Carrie Cannaday.*
2. **Delivery**—Delivery of the finished DVDs (and Blu-ray disc, if purchased) will come 8 weeks after the event. All prices include 3 copies of the DVD (or DVDs, if the project must be split onto multiple DVDs)
3. **Packages**—Details of package contents are set at the time of booking. Any changes made after booking will not apply to this event. As of booking, the packages include the following:
 - **Old School:** Ceremony (2 cameras), Reception, Highlights
 - **Wedding Reality:** Pre-ceremony, Ceremony (3 cameras), Reception, Our Music Video
 - **FilmStar:** Our Story, Rehearsal, Rehearsal Dinner, Pre-ceremony, Ceremony (3 cameras), Reception, Wedding Trailer
4. The Client is responsible for ensuring that adequate permissions and clearances have been granted for taping in all venues.
5. Although Starscape Media makes every effort to provide the highest quality product, conditions outside of our control can degrade video quality, including but not limited to bad weather, overly inadequate lighting, or immovable physical obstructions to taping. Starscape Media cannot be held responsible for such conditions degrading the quality of the product.
6. Starscape Media reserves the right to use any video for promotion, display, publication or other purposes. Starscape Media retains all copyrights to raw footage and masters produced.
7. The Client may terminate this agreement for any reason prior to the day of the event. Should the Client opt for early termination, Starscape Media will retain the deposit.
8. If Starscape Media fails to fulfill this agreement for any unforeseen reason, including but not limited to severe personal injury or illness, death of a loved one, equipment failure, or act of God, Starscape Media will refund 100% of any deposit or money paid.
9. Any defects in the delivered DVDs or Blu-ray disc (if purchased) must be reported to Starscape Media within 14 days of final delivery. Raw footage is retained by Starscape Media for only 2 months after delivery of the final videos. Master copies of edited videos are retained for only 1 year after final delivery.
